## Member/Applicant Disclosure Form

Information obtained is not an automatic bar of membership, employment or volunteer opportunity, but is considered in view or relevant circumstances. In order to be considered, an applicant is required to complete this disclosure. If the applicant is under the age of eighteen, the applicant's parent or guardian must complete the form on behalf of the applicant. Any falsifications, misrepresentations, or incompleteness in this disclosure alone is grounds for disqualification or termination, wherever said falsifications, misrepresentations, or incompleteness is discovered.

By signing this form, I am certifying that I have not been found guilty or entered a plea of guilty or nolo contendere (no contest), regardless of the adjudication, to any of the following charges under the provisions of the Florida Statutes or under any similar statute of another jurisdiction. I also certify that I do not have a delinquency record that is similar to any of these offenses.

I understand I must acknowledge the existence of any criminal records relating to the following list regardless of whether or not those records have been sealed or expunged. I understand that I am obligated to notify the Largo Central Railroad, Inc. of any possible disqualifying offenses that may occur while a member of the Largo Central Railroad, Inc. If you have been found guilty or entered a plea of guilty or nolo contendere, you may not work in any position involving the public unless you apply for and are granted an exemption from the Florida Department of Children and Families.
